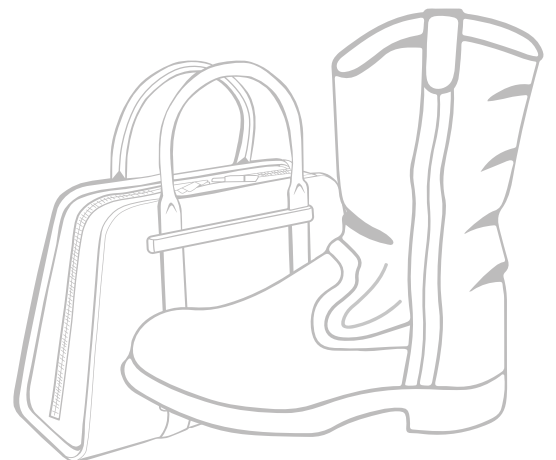

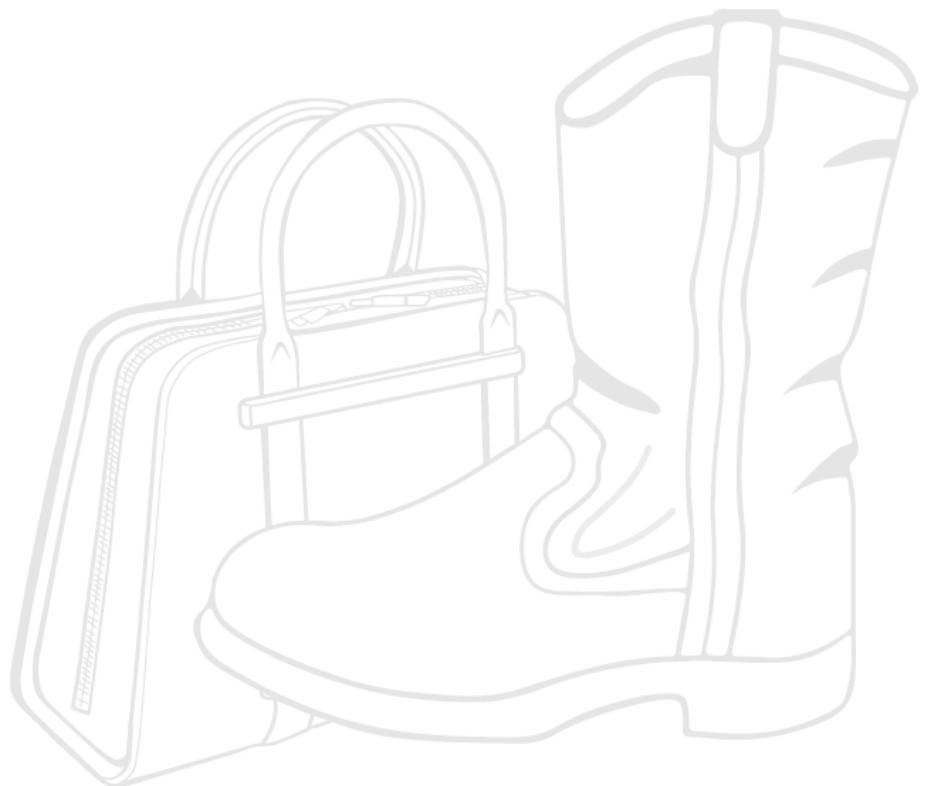

# Minutes of the 17th Annual General Meeting

**Minutes of the 17<sup>th</sup> Annual General Meeting of Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB) held on Saturday, 9<sup>th</sup> January, 2021 at 11:00 am at Six Seasons Hotel, House No. 19, Road No. 96, Gulshan -2, Dhaka 1212.**

The 17<sup>th</sup> Annual General Meeting of Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB) held on Saturday, 9<sup>th</sup> January, 2021 at 11:00 am at Six Seasons Hotel, House No. 19, Road No. 96, Gulshan -2, Dhaka 1212. Mr. Md. Saiful Islam, President of LFMEAB presided over at the AGM session.

After quorum of the meeting, the President called the meeting to order. With the permission of Chair, Ms. Kazi Roushan Ara, Executive Director of LFMEAB read out the Notice of 17<sup>th</sup> Annual General Meeting for the year July 2019-June 2020, which was circulated earlier. Afterwards, President welcomed all the members present at the AGM and proceeded with the meeting according to following agenda:

1. To confirm the minutes of the 16<sup>th</sup> Annual General Meeting held on Saturday, 8<sup>th</sup> August, 2019.
2. Presentation of the Annual Report 2019-2020 of the Executive Committee and adoption thereof.
3. Presentation of the audited accounts of the Association for the year July 2019-June 2020 and auditor's report thereon.
4. To appoint auditor for the July 2020-June 2021 and determine their remuneration.
5. Announcement of the new Executive Committee for the year 2021-2023 by the Chairman, Election Board.

### **Agenda-1: to confirm the minutes of the 16<sup>th</sup> Annual General Meeting held on Saturday, 8<sup>th</sup> August, 2019.**

The minutes of the 16<sup>th</sup> Annual General Meeting held on Saturday, Saturday, 8<sup>th</sup> August 2019 at Six Seasons Hotel, House No. 19, Road No. 96, Gulshan -2, Dhaka 1212, circulated among the General Body members earlier and placed before the AGM for approval. President invited comments from members on the tabled minutes. President, LFMEAB proposed that if there was no objection, the minutes might be treated as read and confirmed. Having received no revisions or observations from anyone, on a proposal from Mr. Hedayetullah Ron, Managing Director,

Footbed Footwear Limited. and seconded by Mr. Md. Nasir Khan, Managing Director, Five-R-Footwear Ltd. the meeting confirmed the minutes.

**Agenda-2: presentation of the Annual Report 2019-2020 of the Executive Committee and adoption thereof.**

In the presentation of the Annual Report 2019-2020, President highlighted the state of economy home and abroad as well as industry export performance with the context of The COVID -19 pandemic; major initiatives taken by the association in 2019-2020, and finally presented summary of the financial statement.

At the beginning President stated that the COVID -19 pandemic has disrupted the entire supply chain and usual business, which impacted life and livelihood. It resulted slowing down global and national economy. As per IMF's global economic outlook of June 2020, advanced economies are projected to contract by 8% in 2020. Nationally, growth plunged to an over 10-year low in FY 2020 (July 2019–June 2020), amid unprecedented contractions in merchandise exports although gradually, economic conditions seem to have been gradually improving after the easing of restrictions in May. In industry level, overall export earnings from leather, leather products and leather footwear combined sector fell by almost 22% in fiscal year July-June 2019-20 over July-June 2018-19. In FY 2018-19, its export earnings recorded \$1019.78 million whereas in just concluded FY 2019-20 it fetched \$797.6 million only! Leather Products registered a drop in exporting revenue of close to 11% to \$220.55 million in FY 20, which was \$247.28 million in FY 19; while, leather footwear declined by over 21% to \$478.75 million in FY 2019-20 from \$607.88 million in FY 2018-19. The industry has been severely impacted by the COVID-19 as massive supply chain disruption and Bangladesh's major export destinations, such as the US, Italy, Spain, UK and Germany opted for nationwide lockdowns or placed restrictions.

Hence, President informed the house that in order to support its members and stakeholders in the context of Covid-19, LFMEAB took the initiatives such as prepared sector specific guideline and easy-to-follow digital health safety communication materials following World Health Organization (WHO), Government and other global standards, initiated COVID – 19 compliance response-cell to disseminate information, and to guide, train and monitor the members regularly,

launched dedicated 24/7 hotline service for any emergency, agreement with Prava Health Care & Shahid Sheikh Fazilatunnesa Mujib KPJ Hospital to avail prioritized services for member factories from where more than 100 member factories have availed these services, and donated PPE for frontline Covid-19 volunteers of Al-Markazul Islami Bangladesh.

Apart from Covid-19 related activities, association has carried out regular activities. President stated that in the reporting period, Compliance Unit has conducted a total of 108 social compliance assessments in 92 different factories and provided trainings such as use of PPE at the workplace, management guidance and operational procedures, infection prevention and control (IPC) for novel coronavirus and were attended by 200 participants from 68 factories. Next, association's DEDO Unit has ascertained in total 14 coefficient with 151 styles of footwear and leather goods for member factories. Furthermore, apart from regular and continuous services under the collaboration with Leather Sector Business Promotion Council (LSBPC), LFMEAB has organized 8 trainings for member factories. Last but not least, like every year, Ministry of Commerce & LFMEAB have jointly organized the third edition of BLLISS from 30<sup>th</sup> October-2<sup>nd</sup> November, 2019, which has been inaugurated by the H.E Sheikh Hasina, MP, the Honourable Prime Minister of the People's Republic of Bangladesh. BLLISS 2019 showcased the products of leading leather goods and footwear manufacturers of the country and provided opportunities for investors and buyers to gain a holistic idea about the leather products and footwear sector in Bangladesh. In 3<sup>rd</sup> edition of BLLISS, for the first time, LFMEAB has invited all Commercial missions of Bangladesh in abroad and major missions' Commercial Chiefs/representative such as Japan, Spain, Canada, and Germany have attended this year, which has given them on the spot experience about BLLISS and Bangladesh's capacity in leather products and footwear export in terms of quality, exportability, and sustainability.

Finally, President welcomed new 20 members in the Association and hoped that they will have a productive relations with the association.

President in his concluding remark, appreciated government's policy supports amidst Covid-19 pandemic situation that unprecedentedly has been hampering the export sectors including the leather products and footwear sector. In this regard, he urged government to devise policy supports in a way that equalizes to all export sectors particularly potential and diversified sector

like leather goods and footwear export sector. Particularly, innovative and robust policy measures are required to sustain business and remain competitive in global supply chain during pandemic.

After discussion, on proposal from Mr Riad Mahmud, Managing Director, Shoeniverse Footwear Ltd. and seconded by Mr. Zainal Abedin, Managing Director, ABC Footwear Industries Ltd. the meeting confirmed the minutes.

**Agenda-3: presentation of the audited accounts of the Association for the year July 2019-June 2020 and auditor's report thereon.**

Being requested by the President, Mr. Abdul Momen Bhuiyan, Senior Vice President (Finance) presented the audited accounts of the Association for the year July 01, 2019 to June 30, 2020. There was item wise discussion on the balance sheet, income-expenditure statement and etc. President asked if there is any comment that needs explanation. Members present expressed satisfaction with the financial position of the Association. President then requested for acceptance and adoption of the Annual Audited Accounts. Audited Accounts were accepted and adopted on proposal from Mr. Mr. Ibnul Wara, Managing Director, Austan Ltd. which was seconded by Mr. Ziaur Rahman, Managing Director, Bay Footwear Limited.

**Agenda-4: to appoint auditor for the July 2020-June 2021 and determine their remuneration.**

President informed the house that *Ashraful Haque Nabi & Co., Chartered Accountants* audited the accounts of the Association for the period from July 2019-June 2020 and for the period of July 2020- June 2021, they submitted Express of Interest (EoI) to undertake audit and Executive Committee being satisfied has proposed the same audit firm to appoint for the year of July 01, 2020, to June 30, 2021. The meeting confirmed the appointment of *Ashraful Haque Nabi & Co., Chartered Accountants* with remuneration tk. 25,000/- (including VAT & TAX) and adopted on a proposal from Mr. Abdul Momen Bhuiyan, Director, Blue Ocean Footwear Limited. and seconded by Mr. Md. Nazmul Hassan Sohail, Managing Director, Leatherex Footwear Industries Limited.



**Agenda-5: announcement of the new Executive Committee for the year 2021-2023 by the Chairman, Election Board.**

Mr. Chakladar M Alam, Chairman of the Association's Election Board for the year 2021-2023 announced a new Executive Committee for the year 2021-2023. New Executive Committee for the year 2021-2023 are Mr. Md. Saiful Islam has been re-elected as President for the period of 2021-2023. Besides, the President, 6 members of the Executive Committee were re-elected as well. 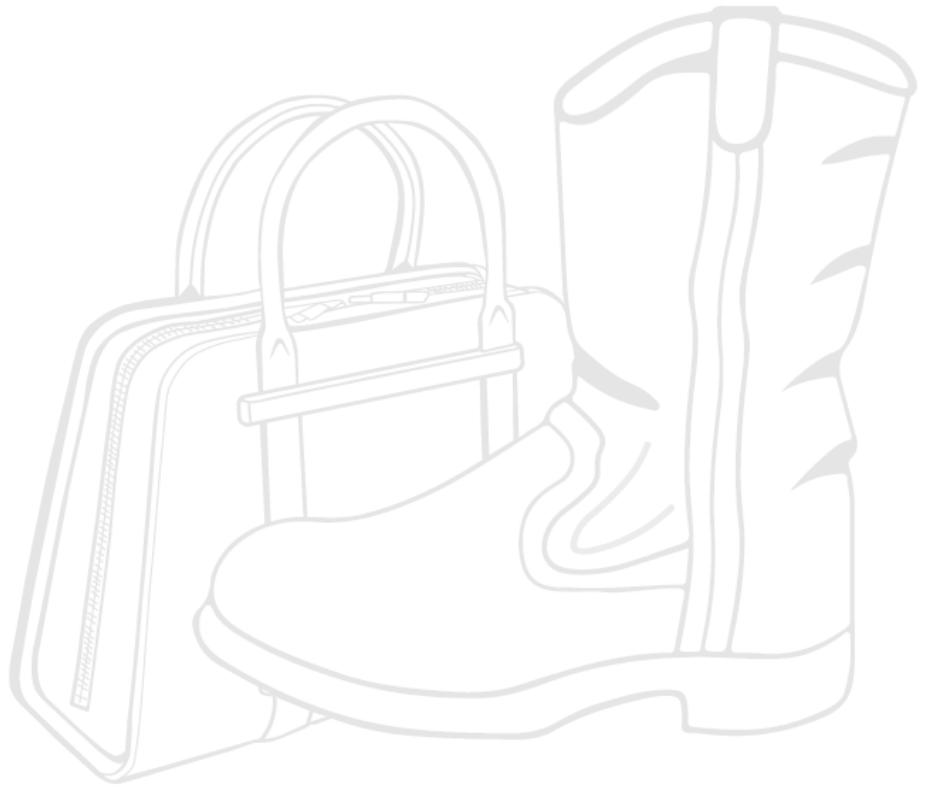
**Vote of thanks**

# ANNUAL REPORT 2020-2021



Dear esteemed members, my colleagues in the Board of Directors, ladies, and gentlemen, Good afternoon!

It is my honor and humble privilege to welcome you all to the 18<sup>th</sup> Annual General Meeting (AGM) of the fiscal year July 2020-June 2021 of Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB).

To begin with, I will highlight the state of the economy in home and abroad, the national outlook of the industry, major initiatives implemented, a summary of the financial position, and finally comment on the future course of actions that are needed for the betterment of our members and the advancement of the sector.

## **Global Economic Situation**

The global economy is improving gradually from the COVID-19 outbreak, but the recovery process is very different and uneven among countries. In the World Bank published report titled “Global Economic Prospect, June 2021”, the economic growth is projected at 5.6 percent in 2021 which was contracted to 3.5 percent in 2020. Substantial fiscal support for the economy, policy support, and maximum access to vaccine are the major determinants of this unstable growth.

United Nations Conference on Trade and Development (UNCTAD) reported that global trade growth remained strong during 2021. The value of global trade in goods continued to increase during each quarter of 2021. Global



trade growth was about 24 percent in Q3 2021, on a year-on year basis, significantly higher than pre-pandemic levels, with an increase of about 13 percent relative to Q3 2019. The global trade in goods valued at about US\$ 5.6 trillion set a new all-time record in Q3 2021.

The positive trend for international trade in 2021 is largely the result of the strong recovery in demand due to subsiding pandemic restrictions, economic stimulus packages, and increases in commodity prices. However, the forecast for 2022 remains very uncertain due to several factors including slowing economic recovery, disruptions of logistic networks and increases in shipping costs, geopolitical factors and the regionalization of trade flows, and the additional borrowing of governments to sustain their economies during the COVID-19 crisis.

## National Economic Situation

With the improvement in both services and manufacturing sectors, Bangladesh's economy is showing a sign of recovery. According to the Bangladesh Bureau of Statistics (BBS), the gross national income per capita (GDP) of Bangladesh has gone up by 6.94 percent in the fiscal year July 2020-June 2021, which is the highest in the Asian region. The actual size of the country's GDP expanded to \$416 billion in the last fiscal year.

The export sector appears to have been bouncing back to a positive trend after overcoming the COVID-19 shock. The export

earnings growth was 15.1 percent in FY 2020-21 than FY 2019-20. The amount was 38,758.31 USD million, which was 33,674.21 USD million in the financial year 2019-20. The foreign reserve amount in this period stood at 46.39 USD billion.

Despite the increasing trend of export, exporters are going through a tight business situation due to the pressure from disruptions of logistic networks and increases in shipping costs, and increases in commodity prices and prices of raw materials among others.

Speed to market is now fundamental to remain competitive. Bangladesh's Government is continuously improving the infrastructure and making the communication system smoother. However, port and customs have to be more efficient and logistics performance should be improved significantly. The delay in Chittagong port is increasing due to heavy export-import pressure. Automation and a corporate structure and privatization of the port can be a solution to reduce human interface and lower the lead time.

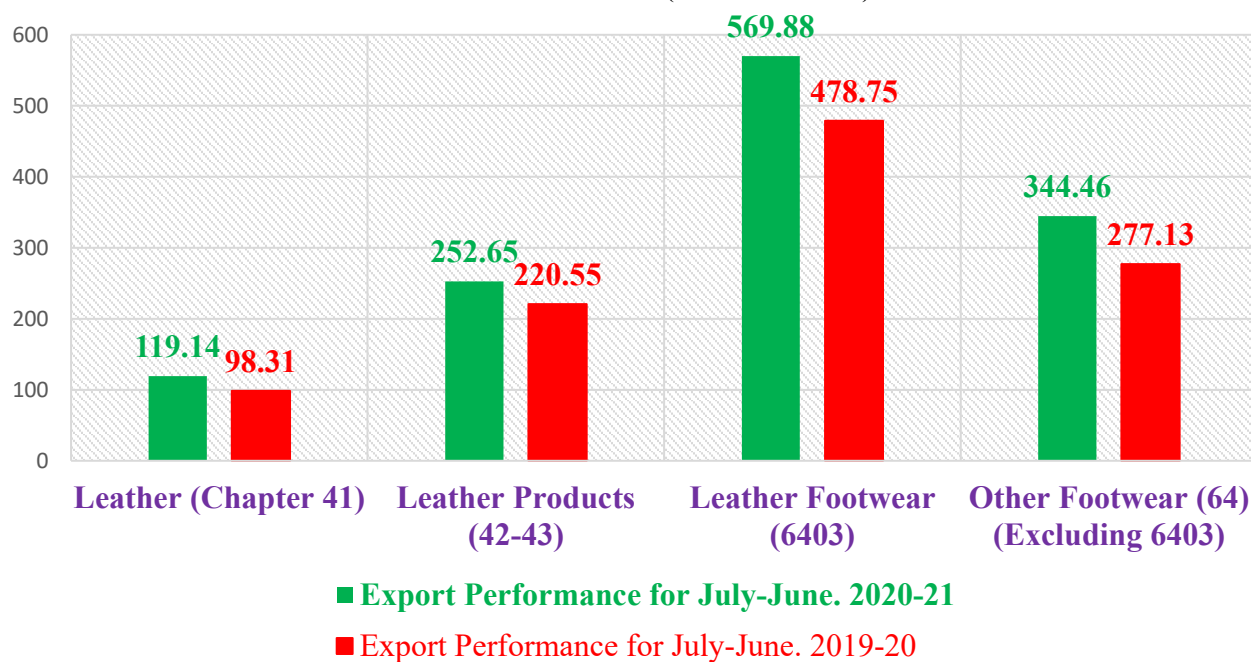
## Industrial Outlook: Export Performance in The Fiscal Year July 2020-June 2021

Export earnings from the country's leather sector, the second-largest earner of foreign currency after the ready-made garments (RMG) industry, witnessed an 18.06% growth in the fiscal year July 2020-June 2021.





**Export Performance for FY July-June, 2020-21 in comparison to FY July-June, 2019-20 (Value in Mn. US\$ )**



It earned 941.67 million USD from Leather & Leather Products (41-43 & 6403) and exported 1,286 USDM from Leather & Leather Products (41-43 & 6403) and Other Footwear (64) (Excluding 6403) together. During the period, Other Footwear recorded over 24% growth indicating the upward trend of export of non-leather footwear. According to the Export Promotion Bureau (EPB), of the total earnings

from the leather sector, Bangladesh earned 119.14 USD million from Leather (Chapter 41) with over 20% growth, 252.65 USD million from Leather Products (42-43) with almost 15% export up, and 569.88 USD million from Leather Footwear (6403) with over 19% growth over the previous fiscal year July 2019-June 2020.

Overall, export performance in the reported period shows that the Bangladesh leather export industry along with its all subsectors surpassed the export performance of the previous financial year. However, a closer look reveals that the export of Leather & Leather Products (41-43 & 6403) is yet (FY 2020-2021) to cross the pre-pandemic level (FY July-June 2018-19), 1019.78 million USD. Though, with a positive note, the total export of Leather & Leather Products (41-43 & 6403) and Other Footwear (64) (Excluding 6403) together reached the pre-pandemic level, 1,291.31 million USD.

### **Activities of LFMEAB Round the Year**

In the reporting period, Association has taken substantive steps to address the needs and concerns of member factories in particular and for the sector in general. Association has worked to serve members better. Major activities and outcomes are highlighted below:

#### ***Compliance Unit***

- Conducted 98 full audits in 85 different member factories.
- Approximately 93% of factories had already covered the employment conditions, such as appointment letter, confirmation letter, ID card, and service book, as required by law.
- 60% of the factories was aided in the development of policy and procedure documents, such as adolescent worker, welfare issues, Occupational health and safety (OHS) issues, compensation issues, service benefits issues, and COVID compliance issues.
- 14662 workers covered by workers' medical insurance.

### ***Beyond Compliance Programs***

- LFMEAB handed over a cheque of 1 Crore Taka to the relief fund of the Honorable Prime Minister on 10<sup>th</sup> June 2021 to support the “Ashrayan Project” under the development initiative of the Government of the Peoples’ Republic of Bangladesh on the occasion of Mujib Borsho.
- In collaboration with ICDDR, B, LFMEAB has inaugurated a seroprevalence survey of COVID-19 among its member factories. From February 2021 to June 2021 ICDDR, B visited 20-member factories of LFMEAB.
- LFMEAB has arranged two orientation programs on active screening for tuberculosis in workplace.
- LFMEAB donated Tk 10 lac to Al-Markazul Islami Bangladesh to smoothly continue services on dignified management of the dead bodies during COVID-19.

### ***Activities and outcomes of Service and Training Department***

#### **The association organized:**

- An online training during the Covid-19 pandemic lockdown for the commercial personnel on coefficient (Shohog) and Utilization Permission (UP) on 8<sup>th</sup> September 2020.
- An online training for HR and Compliance officers on 23<sup>rd</sup> November 2020.
- A virtual training program for the industry commercial personnel on Bonded Warehouse Management on 18<sup>th</sup> November 2020.

- Training on Bonded warehouse management and import availability determination on 31 January 2021.
- A virtual training program for the members on general methods of Quality Control and Inspection for Footwear Manufacturing
- Training on Electric Safety Assessment and Reporting
- LFMEAB office has been shifted from the rented house to its own premises on 1<sup>st</sup> June 2021 at Harbor Gulshan Link

### *Research, policy advocacy, and networking of LFMEAB*

- LFMEAB repeatedly discussed the matter of availing appropriate prappota due to the Order 52/2020 with the member Bond and has resolved the matter with Bond Commissionerate effectively. As a result, Bond Commissionerate has given necessary instructions to Customs Bond Commissionerate to extend up to 60% (over the previous year) or as per the requirement of the LFMEAB member companies.
- As a result of LFMEAB's continuous advocacy, the National Board of Revenue (NBR) issued a letter on 15<sup>th</sup> November 2021 that confirms that it will not issue any expiration date for coefficient.
- LFMEAB became a proud member of The Canada-Bangladesh Joint Working Group (JWG) on Strengthening Commercial Relations.
- LFMEAB in collaboration with Bangladesh Investment Development Authority (BIDA) has organized a webinar on the challenges and

prospects of the leather and leather product sector on Tuesday, 15<sup>th</sup> June 2021. Afterward, LFMEAB and BIDA have prepared an action plan emphasizing customs-related issues for the upgradation of leather products and the footwear export sector and submitted it to relevant government bodies.

### *DEDO Unit of LFMEAB*

- It has ascertained in total 26 coefficients with 144 styles of footwear and leather goods for member factories through factory visit, assessment, calculation of the consumption of raw materials.
- LFMEAB, under the collaboration with Leather Sector Business Promotion Council (LSBPC), has launched a comprehensive commercial handbook, the first of its kind, to facilitate the member factories to run the commercial activities efficiently.

### *LFMEAB-SEIP Skill training program for Leather Sector*

- Currently it is run with a total of 21 active industrial training partners, 1 sectoral dedicated training center: Centre of Excellence for Leather Skill Bangladesh Limited (COEL), and working in 10 different districts in 5 divisions all over the country.
- The successful trainees have been placed to jobs in different member factories of LFMEAB, total job placed 1463 trainees, which is 88.67% of total certified trainees.
- LFMEAB-SEIP (Tranche-03) program will be starting from January 2022 and

will continue till December 2023 and there is a target of train 10,000

unskilled trainees for the leather goods and footwear sector.

### *Financial summary of the fiscal year July 2020-June 2021*

M/s Ashraful Haque Nabi & Co. Chartered Accountants audited the accounts of the Association for the period from July 01, 2020, to June 30, 2021. It appears from the audited accounts that during the period total income of the association was 3,90,13,581 BDT compared to last year's income of 1,89,07,495 BDT while the total expenditure during the period was 2,89,69,980 BDT compared to the previous year's 1,71,59,186 with a net surplus of income over expenditure

BDT. 1,00,43,601 as against the surplus of BDT. 17,48,309 in the previous year.

### **Conclusion**

During the fiscal year July 2020-June 2021, despite different challenges, particularly in the context of the COVID pandemic, the industry has shown its resilience. Our member factories are trying to come out of the Covid pandemic situation that has had a major setback on our factories. Many of us are still facing challenges. In spite of the unprecedented business setback as well as operating underutilization, LFMEAB member factories retained their workforce, which was undoubtedly an incredible service to the society.

Bangladesh's leather products and footwear export sector has come a long way and will continue to grow further. LFMEAB believes that with better efficiency if from all member companies work, and with effective policies are in place, the industry will be able to achieve an export target of USD 2.4 billion by 2024 which is in line with the national export policy 2021-2024.

Finally, I acknowledge the contribution of board members, sincere cooperation from

member companies, LFMEAB team for all their hard work and dedication to making this specific trade body a vibrant business friendly, promising, responsible and respectable platform for building better Bangladesh.

# Activities of LFMEAB Round the Year

## Activities and outcomes of Compliance Unit

- Conducted 98 full audits in 85 different member factories.
- Approximately 93% of factories had already covered the employment conditions, such as appointment letter, confirmation letter, ID card, and service book, as required by law.
- 60% of the factories was aided in the development of policy and procedure documents, such as adolescent worker, welfare issues, Occupational health and safety (OHS) issues, compensation issues, service benefits issues, and COVID compliance issues.
- 14662 workers covered by workers' medical insurance.
- Following the successful compliance intervention, around 85% of total workers have received their identity cards as per the law (Ref.BLR-2015, Form: 06).
- Conducted 10 new membership appraisal assessments and provided provisional membership.
- One compliance-related awareness training was organized where 35 participants from different factories received online training.
- Organized a comprehensive online training program on the implementation of Covid management guidance and operational procedures. Twenty-three participants received training from 18-member factories.
- During the outbreak of Coronavirus, the LFMEAB Compliance team provided advisory, document preparation, and safety policies as per their needs, such as Covid-19 Safety Policy, vehicle recommendation for factory transportation during the movement restrictions by the government, "D" Form process activities for the ease of loan support from the Bank which was declared by the government.

In collaboration with ICDDR, B, LFMEAB has inaugurated a seroprevalence survey of COVID-19 among its member factories. From February 2021 to June 2021, ICDDR, B visited 20-member factories of LFMEAB. This survey provided important insights on the transmission, exposure, and protectiveness of COVID-19 among the factory workforce, which contributed to evidence-informed policymaking to efficiently respond to the COVID-19 pandemic.

#### **Orientation on active screening for tuberculosis in workplace**

Under the beyond compliance initiatives LFMEAB has arranged two orientation programs on active screening for tuberculosis in workplace in collaboration with ICDDR’B on 25<sup>th</sup> October 2021, and 25<sup>th</sup> August 2021. Under this program expertise from ICDDR’B described the process of initial screening of tuberculosis in the workplace and after the course of action. 20-member factories have attended in this program.



### **Celebration of National Children Day**

On the occasion of the National Children Day on 17<sup>th</sup> March 2021, the President of LFMEAB has distributed books among the unprivileged children and motivated them to be attentive to learning and creative participation.

# Activities and outcomes of Service and Training Department

## **Training on Coefficient (Shohog) and Utilization Permission (UP)**

The coefficient is a vital service of LFMEAB. There are so many rules and regulations to take coefficient and Utilization Permission (UP). Therefore, the association arranged an online training during the Covid-19 pandemic lockdown for the commercial personnel on coefficient (Shohog) and Utilization Permission (UP) on 8<sup>th</sup> September 2020. 33 participants attended the training program.

## **Training on Audit, Certification and BSCI Awareness**

During the Covid-19 pandemic lockdown, the association has taken initiatives to roll out its training program through an online platform. To keep the association's members compliant, LFMEAB arranged an online training for HR and Compliance officers on 23<sup>rd</sup> November 2020. 35 participants received training on Audit, Certification, and BSCI awareness.

## **Training on Bonded Warehouse Management**

LFMEAB has arranged an online training program for the industry commercial personnel on Bonded Warehouse Management on 18<sup>th</sup> November 2020. Thirty-seven participants have attended the program. Joint Commissioner; Khulna Mr. Fakrul Amin and one RO were present as the resource persons to give the practical idea and rules of Bonded Warehouse Management. Another training on Bonded warehouse management and import

availability determination on 31<sup>st</sup> January 2021. A total of 40 participants from different member factories have attended the training program.

## **Training on general methods of Quality Control and Inspection for Footwear Manufacturing**

LFMEAB has organized an online training program for the members on general methods of Quality Control and Inspection for Footwear Manufacturing on 22<sup>nd</sup> December 2020. 17 participants from different member factories have participated in the training program.

## **Training on Electric Safety Assessment and Reporting**

LFMEAB, in collaboration with the Leather Sector Business Promotion Council, Ministry of Commerce, has conducted an electrical assessment in the factory workplace in the leather goods and footwear industries to identify the hazards and guide the factory to mitigate them. As part of the first phase, 21 leather goods and footwear factories came under this program. Among them, 18 factories received preliminary assessments and 3 factories received a detailed assessment. After the physical assessment, the consultant prepared a report for each factory and provided a combined report with their overall findings. Under this initiative, one finding sharing program was arranged on 14<sup>th</sup> June 2021 at the Conference room of the Ministry of Commerce, in the presence of the honorable

Commerce Secretary. Also, one training on follow up assessment on electric and fire safety and one capacity building training of the LFMEAB staff has been organized under this initiative.

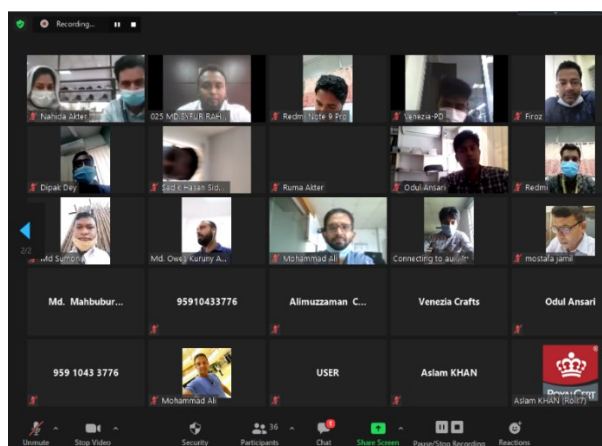

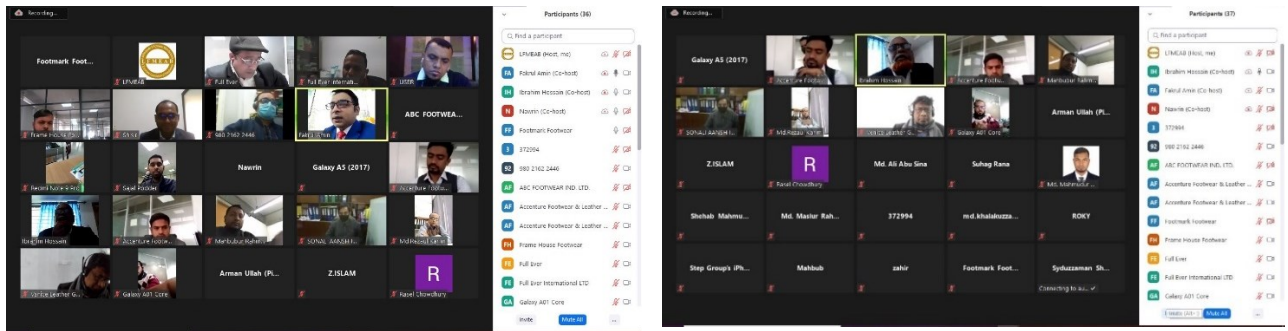

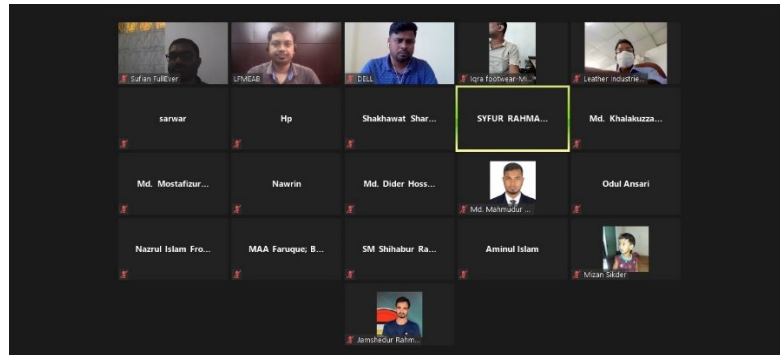

# Research, Policy Advocacy, and Networking of LFMEAB

## Resolving the Prappota Problem

Most LFMEAB member companies had been facing problems regarding availing appropriate prappota due to the Order 52/2020 (adding 20% over the previous year) issued by the National Board of Revenue (NBR). LFMEAB repeatedly discussed this matter with the member Bond and has resolved the matter with Bond Commissionerate effectively. As a result, Bond Commissionerate has given necessary instructions to Customs Bond Commissionerate to extend up to 60% (over the previous year) or as per the requirement of the LFMEAB member companies.

## Making the process of availing coefficient easier for the member factories

As a result of LFMEAB's continuous advocacy, the National Board of Revenue (NBR) issued a letter on 15<sup>th</sup> November 2021 that confirms that it will not issue any expiration date for coefficient. The respective factory will only apply to revise the coefficient in need of including any new materials of a new style or to revise the consumption. It really helped to ease the repeated process of availing coefficient for the member factories.

## LFMEAB's Representation in International Footwear Forum 2021

Syed Nasim Manzur, Advisor to the Executive Committee of the Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB) and Managing Director, Apex Footwear Ltd. represented LFMEAB at the fourth edition of the International Footwear Forum to be virtually held on Tuesday 2<sup>nd</sup> February 2021, organized by The European Footwear Confederation (CEC). The IFF 2021 brought together 25 associations from 24 countries across the globe to discuss common challenges for the footwear industry worldwide. The speakers at the IFF 2021 insisted that trade policy be well fitted to the new challenges that emerged from the pandemic crisis that has disrupted the fashion supply chain, from sourcing to store economics. Trade will play a big role in the recovery, but only if its approach and the agreements upholding it are modernized and better tailored to the new reality. They also highlighted the COVID-19 crisis will result in long-lasting changes in consumer demand, consumer behavior, and retail models. Finally, the IFF 2021 ended with a positive note the digital and

eCommerce are creating new opportunities to set up efficient digital strategies and attract new consumers.

### **Courtesy visit of H.E. Mr. Enrico Nunziata, Ambassador of Italy to Bangladesh at LFMEAB**

H.E. Mr. Enrico Nunziata, Ambassador of Italy to Bangladesh has paid a courtesy visit at the LFMEAB office on 15<sup>th</sup> June 2021. The Board of directors led by the President of LFMEAB welcomed H.E at the association office and discussed bilateral issues. They discussed that Bangladesh and Italy can create mutually beneficial relations in order to materialize each other's competencies and enhance respective competitiveness in the global supply chain. One clear area of collaboration is: Italy can cater Italian artisanship, design skills, and transfer of know-how to Bangladesh while Bangladesh can provide middle to upper ends compliant and quality products at a reasonable price to Italy. LFMEAB proposed to forge mutual relations with Italian counterparts such as Assocalzaturifici, Accademia della Moda/ Institute of Universal Art and Design, Arsutoria School, and CIMAC – Italian Centre for Footwear Application Materials.

### **Pre Budget-Meeting of National Budget FY 2020-2021 at National Board of Revenue**

An LFMEAB team led by President Mr. Md. Saiful Islam took part in the Pre-Budget-Meeting of National Budget FY 2020-2021 on 28th March 2021 at the National Board of Revenue. The Chairman of the NBR presided over the meeting. LFMEAB has submitted and discussed various issues on the national budget FY 2020-21 for the betterment of the member factories and the industry. Different sectors along with BGMEA, BKMEA were present there.

Similarly, in a pre-Budget-Meeting of National Budget for the fiscal year 2021-22, the association leaders also sought fiscal aid for green industries along with other fiscal supports to stay competitive in international market amid the Covid-19 pandemic fallout. LFMEAB also sought reduction of corporate income tax and source tax on export to stay competitive in global market. The LFMEAB leaders said the corporate income tax rate for the sector should be consistent with other export-oriented sectors.



## **Announcement of Child Labor Free Industry**

Ministry of Labor and Employment has initiated direct audit programs by the National monitoring core committee and has paid a random visit at 11-member factories to endorse this sector as child labor free. Afterward, on 4<sup>th</sup> March 2021 Ministry of Labor and Employment in the presence of the Honorable State Minister Ms. Munnujan Sufiyan has announced Leathergoods and Footwear Sector as Child Labor free.

## **Courtesy visit of Executive Chairman of NSDC**

The Executive Chairman of the National Skill Development Council has paid a courtesy visit at LFMEAB on 30<sup>th</sup> January 2021. The team of the National Skill Development Corporation (NSDC) discussed skill development programs for the leathergoods and footwear sector with the President of LFMEAB and his team.

## **Sensitizing and facilitating member factories to complete the REX registration process**

The REX system is based on the principle of self-certification by exporters. Under the system, the exporters themselves issue the statements on the origin of each consignment of goods to be exported to the EU with the duty-free facility. To be entitled to issue the

statements on origin, all local exporters need to be registered with the EU database, known as the REX system, through the Export Promotion Bureau (EPB). In the beginning, it was a new and cumbersome process for most of the members, particularly for the small and medium factories. LFMEAB continuously sensitized members regarding Rex Registration Number and extended assistance to complete the process successfully. The REX system has contributed to simplify export formalities as well as to reduce workload, cost of the exporter and administrative burden.

## **Online Focused Group Discussion (FGD) on Leather Sector with Ministry of Foreign Affairs**

LFMEAB in collaboration with Ministry of Foreign Affairs - Division of Trade, Investment and Technology – has organized a webinar on "Enhancing Exports of Leather Goods and Development of the Leather Industry: Challenges, Opportunities and the Way forward" held on 04 November 2020 at 2.00 PM. The webinar was presided over by Mr. Masud Bin Momen, Honourable Foreign Secretary of Bangladesh. Dr Khalilur Rahman, the High Commissioner of Bangladesh in Canada, was present among other dignitaries. Many Chairpersons and Managing Directors of

LFMEAB member companies joined the webinar.

Syed Nasim Manzur, Advisor to the Executive Committee of the Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB) and Managing Director, Apex Footwear Ltd. delivered a sectoral presentation highlighting prospects and scalable challenges of leather products and the footwear export industry with particular attention to trade, investment, and technological upgradation.

Honorable Foreign Secretary has emphasized diversification of export base, product innovation, and new market access for exports as well as finding new ways of competitiveness. Hence, Foreign Secretary assured all-out cooperation from the Ministry of Foreign Affairs, particularly from commercial missions to enable exporters of Bangladesh leather products and footwear export industry in strengthening their position in traditional markets and accessing new export markets.

### **LFMEAB became a proud member of The Canada-Bangladesh Joint Working Group (JWG) on Strengthening Commercial Relations**

LFMEAB became one of the distinguished members of The Canada-Bangladesh Joint Working Group (JWG) on Strengthening

Commercial Relations. The JWG is a group of eight private sector representatives, four from Canada, four from Bangladesh, invited by our respective governments to make high-level recommendations on ways to facilitate and diversify the trade between our countries. JWG members will draw from their own international trade expertise and consult with organizations directly involved in Canada-Bangladesh commercial relations.

Mr. Md. Saiful Islam, President, of LFMEAB has already submitted a Study Report on the prospects of Bangladesh's leather, leather products, and footwear export sector in Canada and emphasized meaningful collaboration with counterparts such as the Shoe Manufacturers Association of Canada (SMAC), Western Canadian Shoe Association, Luggage, Leathergoods, Handbags and Accessories Association of Canada, and Association of Footwear and Apparel Canada.

### **Webinar on the challenges and prospects of the leather and leather product sector**

LFMEAB in collaboration with Bangladesh Investment Development Authority (BIDA) has organized a webinar on the challenges and prospects of the leather and leather product sector on Tuesday, 15<sup>th</sup> June 2021 at 11 AM. Honorable Executive Chairman of BIDA Mr. Md. Sirazul Islam presided over the event.

LFMEAB President, distinguished board of Directors of LFMEAB, representatives from different ministries and departments of government, and many Chairpersons and Managing Directors of LFMEAB member companies joined the webinar.

Syed Nasim Manzur, Advisor to the Executive Committee of the Leathergoods And Footwear Manufacturers & Exporters Association of

Bangladesh (LFMEAB) and Managing Director, Apex Footwear Ltd. delivered a sectoral presentation on the challenges and prospects of the leather and leather product sector. 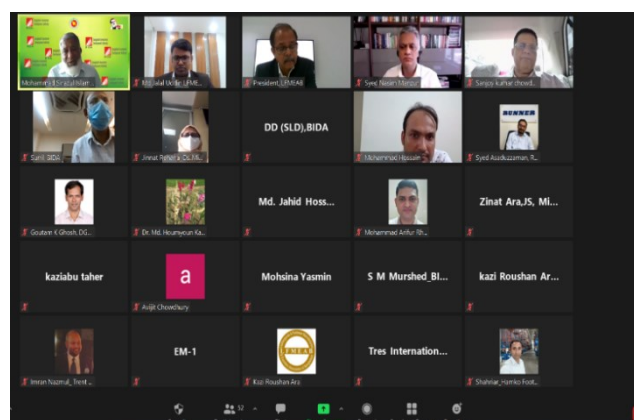

- Supported LFMEAB member factories by analyzing, documentation, and providing a guideline to solve any issues faced by member factories at Customs Bond Commissionerate (CBC).

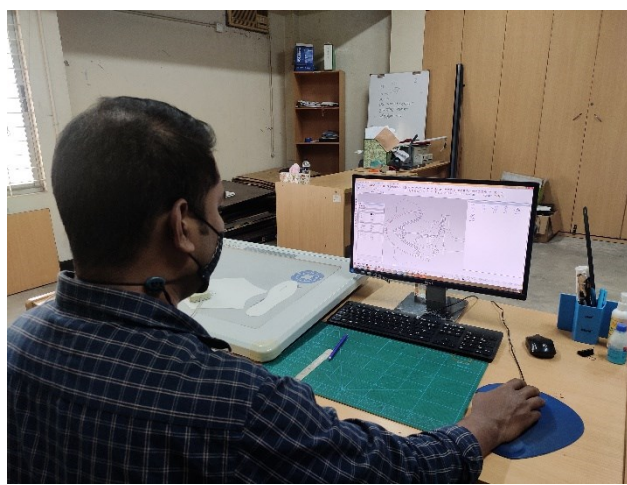
It has also developed 9 footwear last and 6 articles pattern as ordered by the buyer.

# LFMEAB-SEIP Skill Training Program

LFMEAB, in cooperation with Skills for Employment Investment Program (SEIP), Finance Division, Ministry of Finance, Bangladesh, and The Asian Development Bank (ADB), has been implementing a skills development initiative heading “LFMEAB-SEIP Skills Training Program”. Meanwhile, LFMEAB-SEIP has successfully completed the Tranche-01 program that started in May 2016 and ended in December 2017. During the period LFMEAB trained 4,860 unskilled workforces to leather-specific skilled manpower to support the demand of the leather industry. LFMEAB has offered courses in two different segments naming “new entrant training” and “Upskill training”, the new entrant courses were offered to completely unskilled workers who were willing to work for the leather goods and footwear industry, whereas the upskill courses were offered to mid-level executives of the industry. After successful completion of the Tranche-01 program, the Ministry of Finance and ADB extended the LFMEAB-SEIP skills development training program for another term (Tranche- 02) which started from January 2018 and continued till December 2020 to meet the skilled manpower required for the sector. However, the project’s Tranche- 02 phase has been extended for another year up to December 2021 due to the worldwide pandemic situation of COVID-19. In Tranche- 02 LFMEAB-SEIP has a total trainee target is 10,140. Some key outcomes of LFMEAB-SEIP (Tranche- 02), for the period of July 2020 to June 2021:

- Currently it is run with a total of 21 active industrial training partners, 1 sectoral dedicated training center: Centre of Excellence for Leather Skill Bangladesh Limited (COEL), and working in 10 different districts in 5 divisions all over the country.
- Under LFMEAB-SEIP (Tranche- 02), LFMEAB has enrolled a total of 1964 and out of them 1650 trainees successfully completed the training and received certification.
- Among the enrolled, 1107 trainees were female, which is 56.36% of total enrollment.
- The successful trainees have been placed to jobs in different member factories of LFMEAB, total job placed 1463 trainees, which is 88.67% of total certified trainees.

## Future plan

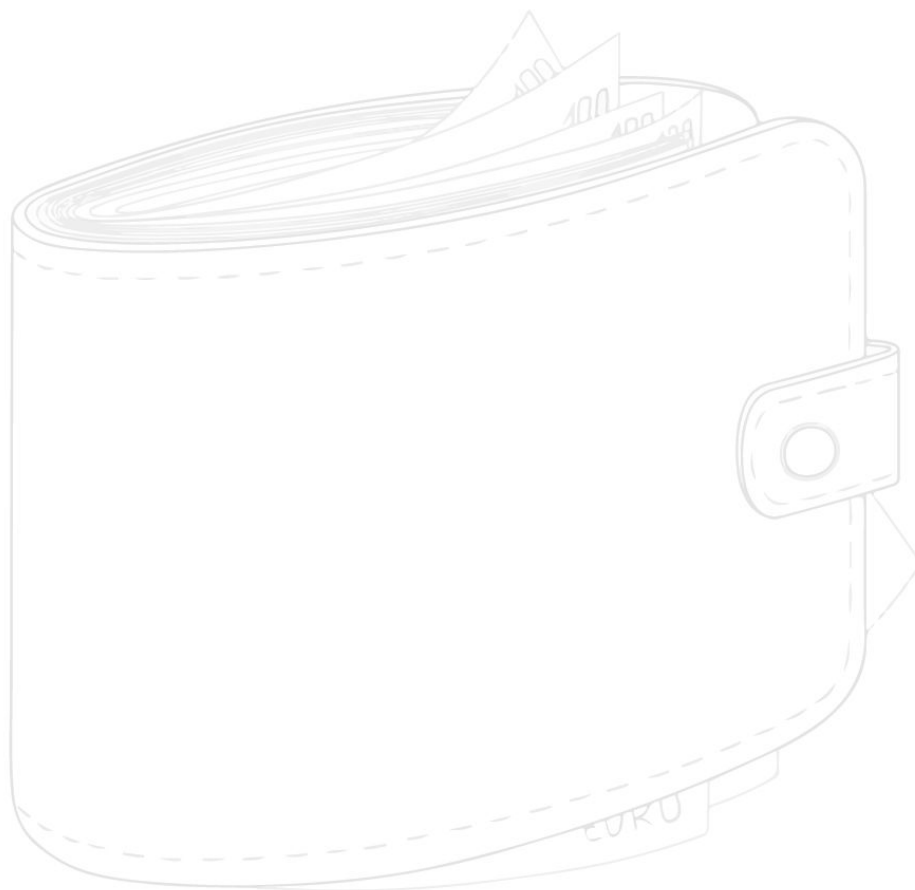
- LFMEAB-SEIP (Tranche-03) program will be starting from January 2022 and will continue till December 2023 and there is a target of train 10,000 unskilled trainees for the leather goods and footwear sector. It is worth mentioning that during the COVID-19 period LFMEAB-SEIP facilitated all skills training programs ensuring social distancing and all other COVID-19 compliance.
- In Tranche-03 there will be two new upskills courses heading “Advanced (Multitasking) Sewing Machine Operation”: training target 400 and “Advanced (Multitasking) Lasting & Finishing Operation”: training target 200 and there will be 07 new entrant courses: Cutting Machine Operation: training target 400, Sewing Machine Operation: training target 4400, Setting Operation (Footwear):



training target 2100, Setting & Assembling Operation (Leather Goods): training target 700, Lasting & Assembling Operation (Footwear): training target 1300, Footwear & Leather goods Design & Development with CAD-CAM: training target 300, Sewing Machine Maintenance: training target 200. Now for providing an improved

training facility LFMEAB is establishing a completely new sewing machine maintenance lab, and upgrading its existing CAD-CAM lab with cutting edge technologies and new machinery at LFMEAB's dedicated training center COEL, Chandra, Gazipur under the Tranche-03 program.

**1.00 Background:**

**1.01 Legal form of the Organization:**

Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB) was established in 2003 as a company limited by guarantee and registered under section 28 of the Companies Act, 1994.

**1.02 Objectives of the Organization:**

LFMEAB is actively promoting vocational training and skill development programs as well as improving working conditions through schemes such as life insurance, health coverage and WPPF.

**2.00 Significant Accounting Policies:**

**2.01 Basis of Accounting:**

The financial statements have been prepared using cash basis of accounting on going concern concept except statement of receipts and payments.

**2.02 Property, Plant and Equipment:**

The cost of an item of Property, Plant and Equipment is recognized as an asset if, it is probable that the future economic benefits associated with the item will flow to the organization and the cost of item can be measured reliably. Property, Plant and Equipment are stated at cost less accumulated depreciation. Cost represents the cost of acquisition includes purchase price and other directly attributable cost of bringing the assets to working conditions for its intended use. **2.07 Capital Fund:**

Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh is registered with the office of the Registrar of the Joint Stock Companies and Firms, Government of the People's Republic of Bangladesh under Section 28 of the Companies Act 1994 as a company limited by guarantee and without capital. The capital fund represents excess of income over expenditures.

**2.08 Reporting Period:**

These financial statements covered one year from 01 July 2020 to 30 June 2021 which is followed consistently.
