**Minutes of the 18<sup>th</sup> Annual General Meeting of Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB) held on Saturday, 12<sup>th</sup> March 2022 at 12:00 AM at MCCI-BEF's conference room, Police Plaza Concord, Tower-2, Level-6, Road-144, Gulshan-1, Dhaka-1212.**

The 18<sup>th</sup> Annual General Meeting of Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB) was held on Saturday, 12<sup>th</sup> March 2022 at 12:00 AM at MCCI-BEF's conference room, Police Plaza Concord, Tower-2, Level-6, Road-144, Gulshan-1, Dhaka-1212. Mr. Md. Saiful Islam, President of LFMEAB presided over the AGM session.

After the quorum of the meeting, the President called the meeting to order. With the permission of Chair, Ms. Kazi Roushan Ara, Executive Director of LFMEAB read out the Notice of 18<sup>h</sup> Annual General Meeting for the year July 2020-June 2021, which was circulated earlier. Afterward, President welcomed all the members present at the AGM and proceeded with the meeting according to the following agenda:

1. To confirm the minutes of the 17<sup>th</sup> Annual General Meeting held on Saturday, 9<sup>th</sup> January 2021.
2. Presentation of the Annual Report 2020-2021 of the Executive Committee and adoption thereof.
3. Presentation of the audited accounts of the Association for the year July 2020-June 2021 and auditor's report thereon.
4. To appoint auditors for July 2021-June 2022 and determine their remuneration.
5. Introduction of the new executive body, President, and office-bearers.

**Agenda-1: to confirm the minutes of the 17<sup>th</sup> Annual General Meeting held on Saturday, 9<sup>th</sup> January 2021.**

The minutes of the 17<sup>th</sup> Annual General Meeting held on Saturday, 9<sup>th</sup> January 2021 at 11:00 AM at Six Seasons Hotel, House No. 19, Road No. 96, Gulshan -2, Dhaka 1212, circulated among the General Body members earlier and placed before the AGM for approval. President invited comments from members on the tabled minutes. The President of LFMEAB proposed that if there was no objection, the minutes might be treated as read and confirmed. Having received no revisions or observations from anyone, on a proposal from Mr. Zainal Abedin, Managing Director,

ABC Footwear Industries Ltd. and seconded by Ms. Amrita Makin Islam, Deputy Managing Director, Picard Bangladesh Limited. the meeting confirmed the minutes.

### **Agenda-2: Presentation of the Annual Report 2020-2021 of the Executive Committee and adoption thereof.**

In the presentation of the Annual Report 2020-2021, President highlighted the state of the economy home and abroad as well as industry export performance; major initiatives taken by the association in 2020-2021, and finally presented a summary of the financial statement.

The President told that the global economy was improving gradually from the COVID-19 outbreak, but the recovery process was uneven among countries. Citing a World Bank report, he told that the economic growth was projected at 5.6 percent in 2021 which was contracted to 3.5 percent in 2020. He stated that the global trade growth remained strong during 2021. However, the forecast for 2022 remained very uncertain due to several factors including slowing economic recovery, disruptions of logistic networks and increases in shipping costs, geopolitical factors, and the regionalization of trade flows. In the state of the national economy, he said with the improvement in manufacturing sectors, Bangladesh's economy was showing a sign of recovery. According to the Bangladesh Bureau of Statistics (BBS), the gross national income per capita (GDP) of Bangladesh has gone up by 6.94 percent in the fiscal year July 2020-June 2021, which was the highest in the Asian region. The export sector bounced back to a positive trend after overcoming the COVID-19 shock. The export earnings growth was 15.1 percent in the financial year 2020-21 than the financial year 2019-20. The amount was 38,758.31 million US\$, which was 33,674.21 million US\$ in the financial year 2019-20. Despite the increasing trend of export, exporters are going through a tight business situation due to the pressure from disruptions of logistic networks and increases in shipping costs, and prices of raw materials among others.

In the leather products, footwear, synthetic export industrial outlook, it earned 941.67 million US\$ from Leather & Leather Products (41-43 & 6403) and exported 1,286 million US\$ from Leather & Leather Products (41-43 & 6403) and Other Footwear (64) (Excluding 6403) together. During the period, Other Footwear recorded over 24% growth indicating the upward trend of export of non-leather footwear. Of the total earnings, it earned 119.14 million US\$ from Leather (Chapter 41) with over 20% growth, 252.65 million US\$ from Leather Products (42-43) with almost 15%

export up, and 569.88 million US\$ from Leather Footwear (6403) with over 19% growth over the previous fiscal year July 2019-June 2020.

In the reporting period, the association has taken substantive steps to address the needs and concerns of member factories in particular and for the sector in general. Association has worked to serve members better. In this regard, the association's Compliance Unit has worked to enhance compliance. As a result, approximately 93% of factories had already covered the employment conditions as required by law. Besides, under the Beyond Compliance initiatives, LFMEAB handed over a cheque of 1 Crore Taka to the relief fund of the Honorable Prime Minister on 10<sup>th</sup> June 2021 to support the "Ashrayan Project" under the development initiative of the Government of the Peoples' Republic of Bangladesh on the occasion of Mujib Borsho.

Association's service and training department organized various training on bonded warehouse management and import availability determination, General Methods of Quality Control and Inspection for Footwear Manufacturing for the commercial personnel, HR, and Compliance officers. During the period, LFMEAB in collaboration with Bangladesh Investment Development Authority (BIDA) has organized a webinar on the challenges and prospects of the leather and leather product sector on Tuesday, 15<sup>th</sup> June 2021. Afterward, LFMEAB and BIDA have prepared an action plan emphasizing customs-related issues for the up-gradation of leather products and the footwear export sector and submitted it to relevant government bodies. Furthermore, LFMEAB became a proud member of The Canada-Bangladesh Joint Working Group (JWG) on Strengthening Commercial Relations. President also informed the meeting that the Tranche-03 of LFMEAB-SEIP Skill training program for Leather Sector will be starting from January 2022 and will continue till December 2023 and there is a target of train 10,000 unskilled trainees for the leather goods and footwear sector. Finally, President welcomed 10 new members and hoped they will have long and productive relations with the Association. After discussion, on the proposal from Mr. M. Amirullah, Managing Director, H.N. Shoes Ltd., and seconded by Mr. Ibnul Wara, Managing Director, Austan Ltd. the meeting confirmed the minutes.

# Annual Report 2021-2022

Dear esteemed members, my colleagues in the Board of Directors, ladies, and gentlemen,  
Good evening!

It is my honor and humble privilege to welcome you all to the 19<sup>th</sup> Annual General Meeting (AGM) of the fiscal year July 2021-June 2022 of Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB).

To begin with, I will highlight the state of the economy home and abroad, the national outlook of the industry, major initiatives implemented, a summary of the financial position, and finally comment on the future course of actions that are needed for the betterment of our members and the advancement of the sector.



## Global Economic Situation

While the world was slowly recovering from COVID, is now likely to face a global recession in 2023 due to the rises in interest rates in response to higher inflation. The harmful impacts of the war in Ukraine looks will be lingering. According to OECD Economic Outlook, Interim Report September 2022, global GDP stagnated in the second quarter of 2022 and output declined in the G20 economies. High inflation is persisting for longer than expected. As a result, global growth is projected to remain subdued in the second half of 2022, before slowing further in 2023 to an annual growth of just 2.2%. As per United Nations (UN) publication ‘World Economic Situation and Prospect 2022’, more optimistically, the global economy is expected

to grow by 3.5 percent in 2023. This bleak economic situation is creating slow market demands and sluggish manufacturing activities. Consequently, overall, a supply chain disruption is being observed.

### **National Economic Situation**

With the improvement in both services and manufacturing sectors, Bangladesh's economy is showing a sign of recovery. According to the Bangladesh Bureau of Statistics (BBS), the economy of Bangladesh has grown up by 7.25 percent in the fiscal year of 2021-22. However, World Bank estimated it at 6.4 percent in the same period. As per BBS, the gross national income per capita (GDP) of Bangladesh stands at \$465 billion in the 2021-2022 fiscal year from \$416 billion the previous year. Bangladesh's per capita income reached 2,824 U.S. dollars in the fiscal year 2021-2022. According to World Bank, the growth rate is likely to be 6.7 percent for fiscal 2023 boosted

### **Industrial Outlook: Export performance in the fiscal year July 2021-June 2022**

Export earnings from the country's leather, leather products, and footwear sector; the second-largest earner of foreign currency after

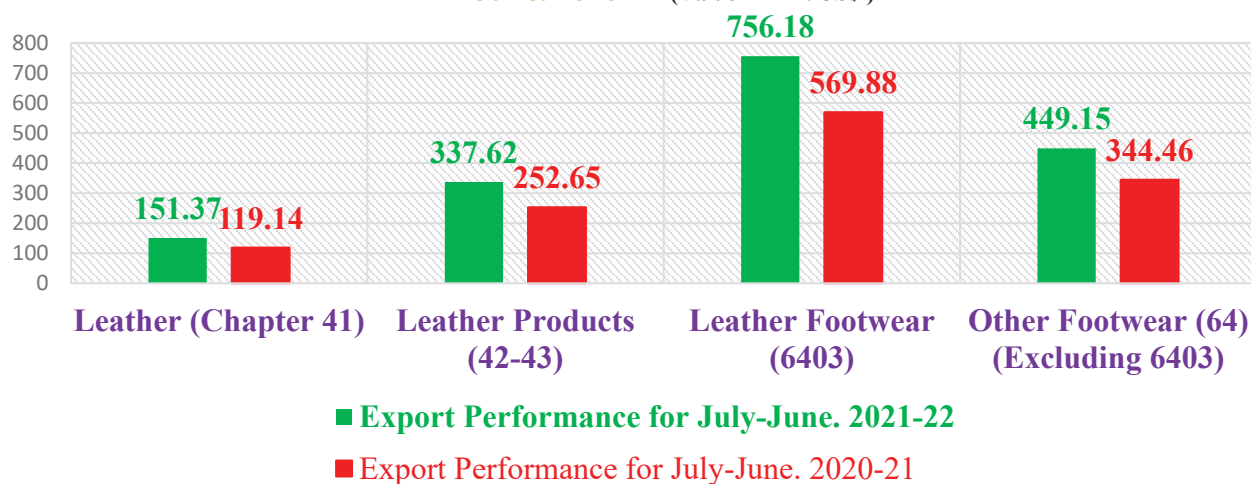
by an increase in investment and remittance income for the country.

According to the Export Promotion Bureau (EPB), the export earnings of Bangladesh stood up by \$52.08 billion through exports in the FY 2021-22, with a 34.38% year-on-year growth. For the first time in history that export earnings crossed the milestone of \$50 billion.

Even if the export earnings growth is encouraging but export and exporters expressed concerns about whether the growth would sustain further as the global economy is facing a surge in higher inflation, the Russia-Ukraine war, recession in different regions, etc. Exporters are going through a tight business situation due to the pressure from disruptions of logistic networks and increases in shipping costs, inadequate energy supply, high inflation, and increases in commodity prices and prices of raw materials among others. The export earnings show robust growth due to the shipment of the orders for Christmas and the growth might slow down afterward.

the ready-made garments (RMG) industry, witnessed 32.23% growth in the fiscal year July 2021-June 2022.

**Export Performance for FY July-June. 2021-22 in comparison to FY July-June. 2020-21 (Value in Mn. US\$)**



It earned 1245.18 million USD from Leather & Leather Products (41-43 & 6403) and exported 1694.33 USDM from Leather & Leather Products (41-43 & 6403) and Other Footwear (64) (Excluding 6403) together. During the period, Other Footwear recorded more than 30% growth over SPLY indicating the upward trend of export of non-leather footwear. According to the Export Promotion Bureau

(EPB), of the total earnings from the leather sector, Bangladesh earned 151.37 USD million from Leather (Chapter 41) with over 27% growth, 337.62 USD million from Leather Products (42-43) with almost 34% export up, and 756.18 USD million from Leather Footwear (6403) with nearly 33% growth over the previous fiscal year July 2020-June 2021.

Overall, export performance in the reported period shows that the Bangladesh leather export industry along with its all subsectors surpassed the export performance of the previous financial year with an upward growth trend. Total export of Leather & Leather Products (41-43 & 6403) and Other Footwear

(64) (Excluding 6403) reached 1694.33 USDM in FY 2021-22, whereas it was 1286.13 USDM in FY 2020-21.

### **Financial Summary of the Fiscal Year July 2021-June 2022**

M/s Ashraful Haque Nabi & Co. Chartered Accountants audited the accounts of the Association for the period of July 01, 2021 to June 30, 2022. It appears from the audited accounts that during the period total income of

the association was BDT 2,20,42,412/- compared to last year's income of BDT 3,90,13,581/- while the total expenditure during the period was BDT. 2,20,35,836/- compared to the previous year's BDT 2,89,69,980 with a net surplus of income over expenditure BDT 6,576.

## Conclusion

During the fiscal year July 2021-June 2022, despite different challenges, particularly in the context of the post-Covid slow recovery, the war in Ukraine, and the sluggish economic activities in major export markets; the industry has shown its resilience. Overall, the leather, leather products, and footwear sector, as a whole, showed over 30% growth and closer to 2 billion (1700 USDM) export. Thus, Bangladesh's leather products and footwear export has come a long way and will continue to grow further. The government's policy support particularly allowing importers to use central bonded warehouse for building stock of inputs duty-free for faster import of inputs and to ease access to export; reducing 50% of total import duties on components for all footwear and leather goods so that local industry can utilize inputs and upgrade their products; and to declare a time-bound and credible action-

plan for completing the Common Effluent Treatment Plant (CETP) at the Savar Leather Industrial Park are critical bottlenecks for the sectoral upgradation. LFMEAB believes that given the right and effective policies are in place, the industry will be able to achieve an export target of USD 3-4 billion by 2025.

Finally, I acknowledge the contribution of board members, sincere cooperation from member companies, LFMEAB team for all their hard work and dedication to making this a vibrant, friendly, and welcoming Association which we are very proud of.

Association has taken applicable steps to address the needs and concerns of member factories in particular and for the sector in general. Association has worked to serve members better. Major activities and outcomes are highlighted below:

- Conducted 68 full announced audits in **66** different factories
- Jointly implement with intra department program on decent work and program on gender-sensitive workplace
- Updated 82 members' profiles by collecting, formulating and analyzing data.
- Supported **65** member factories for noncompliance critical findings mitigation.
- Updated the LFMEAB Audit checklist & reporting protocol

## Audit Status

From July 2021–June 2022, the compliance unit conducted **68** individual factories’ full announced audits, where **15% of factories obtained Grade-A, 9% of factories obtained Grade B, 29% of factories obtained Grade C, and 47% of factories obtained Grade D** as illustrated below:

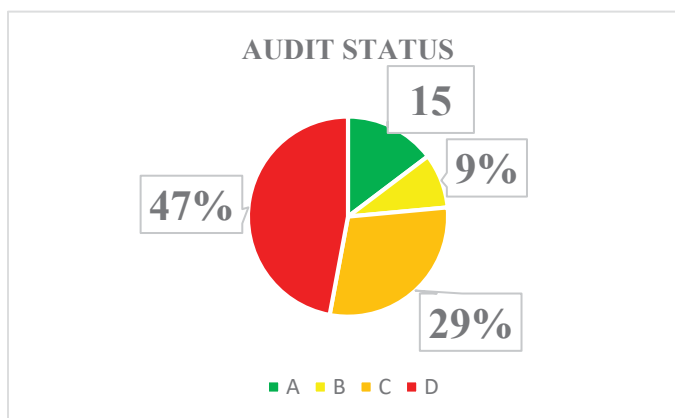
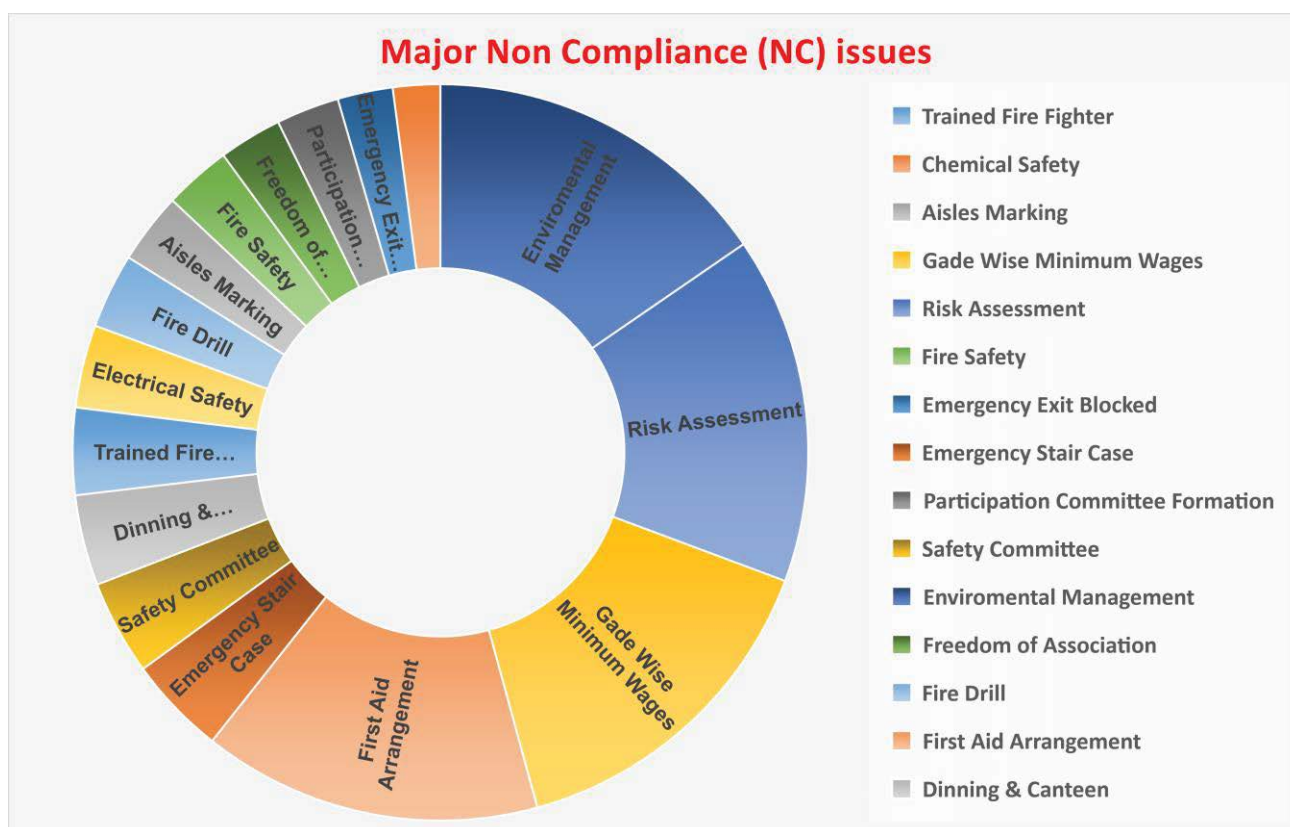


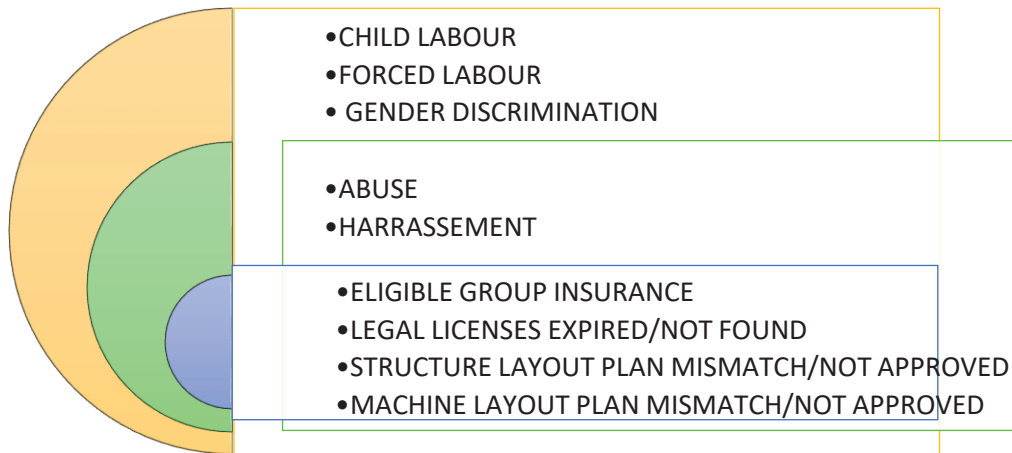
Figure: Audit status at a glance from July 21- June 22

# Research, policy advocacy and networking of LFMEAB

## ALDI visits LFMEAB

ALDI, largely based on EU countries, UK, and US with many distribution centers in Germany and a growing presence in China, visited LFMEAB on Thursday, 12<sup>th</sup> May 2022. In 2019, ALDI started its journey to source

footwear from our member factories. So far ALDI worked with 5 LFMEAB factories. Now ALDI wants to expand its business with member factories.



## BIDA hosted investment session on Leather and Leather Goods

As part of the International Investment Summit (IIS) 2021, the Bangladesh Investment Development Authority (BIDA) hosted an investment session on Leather and Leather Goods on Tuesday, 15<sup>th</sup> June 2021. It discussed opportunities for leather footwear and accessories. The event was chaired by Mr. Amir Hossain Amu, MP, Chairman, Parliamentary Standing Committee on Ministry of Industries while Mr. Syed Nasim

Manzur, Advisor of LFMEAB delivered the keynote presentation, and moderated by Mr. Md. Saiful Islam, President of LFMEAB. Panel discussion was attended by Mr. Ziaur Rahman, Managing Director, Bay Footwear Limited, Mr. Lien Chun Yao, Managing Director, Blue Ocean, Mr. Mike Redwood, Spokesperson, Leather Naturally, and Ms. Deborah Taylor, Managing Director, Sustainable Leather Foundation. The session recommended

simplifying existing customs laws to ease access to export and for faster import of inputs; allowing importers to use central bonded warehouse for building stock of inputs duty-

free; and reducing 50% of total import duties on components for all footwear and leather goods etc.



### Match-making conference with the Chinese market

A virtual match-making conference on sourcing Bangladeshi Leather, Leather Products, & Footwear in the Chinese market was held on Tuesday, 31<sup>st</sup> May at 12 PM BST. It was jointly organized by Bangladesh Embassy in Beijing and LFMEAB. It focused on why the Chinese importers will source Bangladeshi leather, leather products,

footwear, and synthetic products for their market. LFMEAB President delivered a presentation highlighting competitive aspects of sourcing from Bangladesh. The event was attended by various Chinese importers, manufacturers, exporters, and government high officials among other dignitaries.



## Investment opportunity in the Dominican Republic

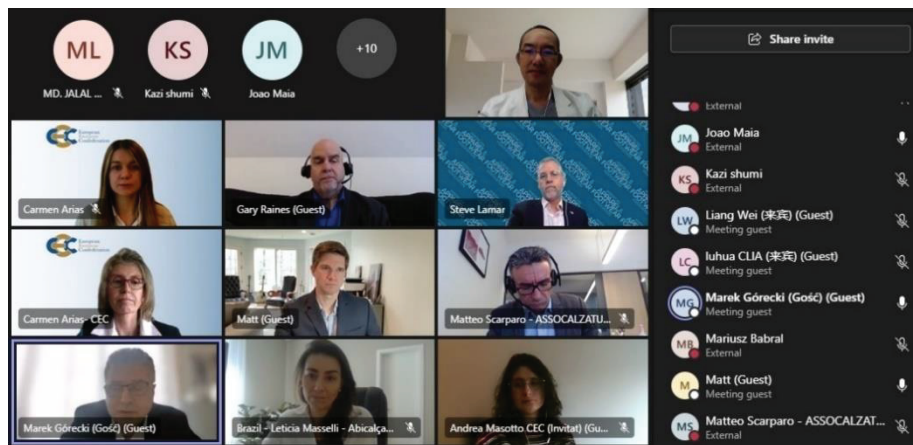
LFMEAB President has had an online courtesy meeting with the Ambassador of the Dominican Republic (DER) in India on Wednesday, 25<sup>th</sup> May 2022. 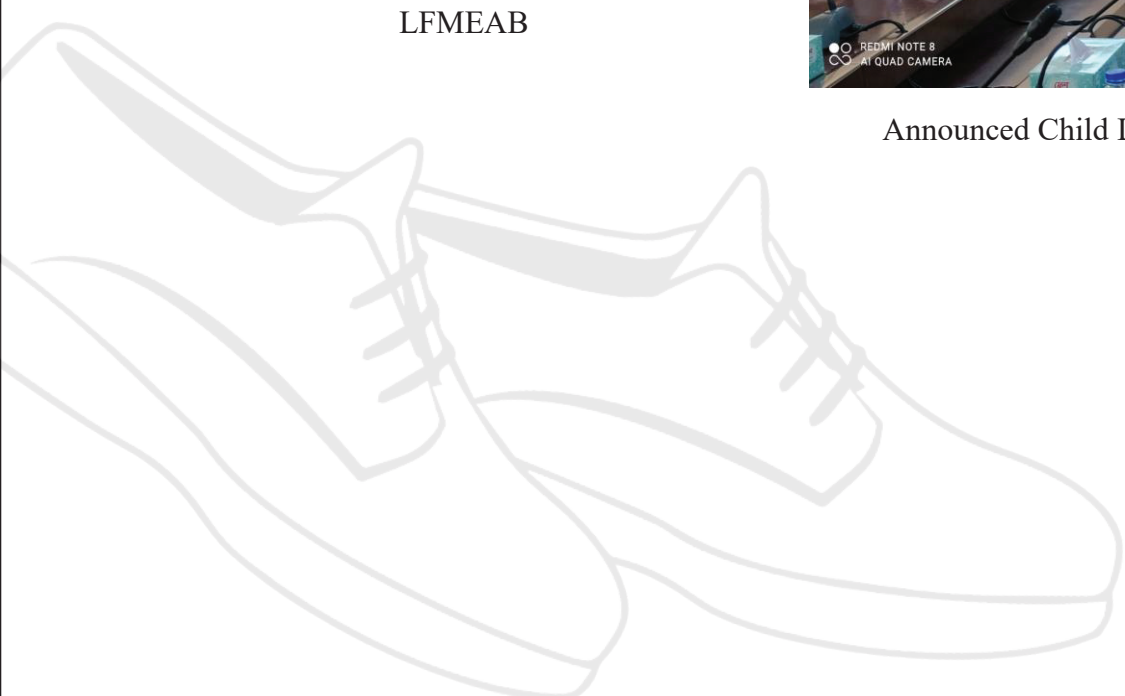

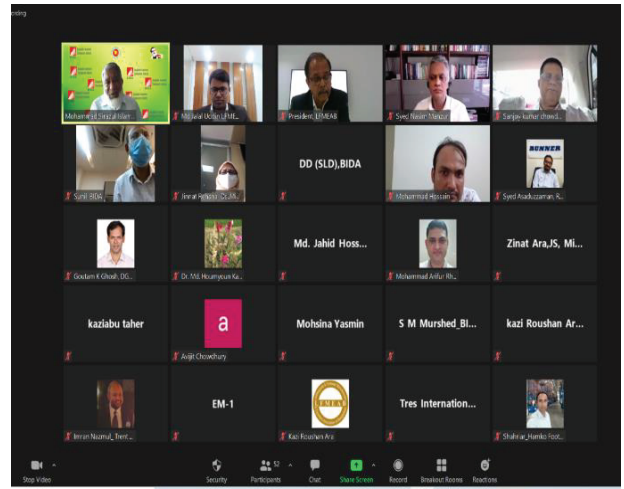

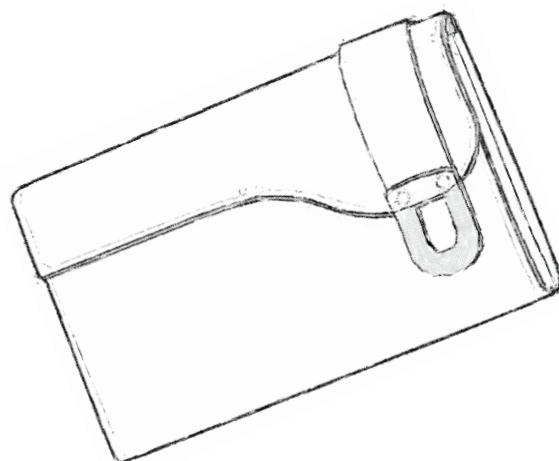

## Published Decent Workplace Toolkit in Leather Sector

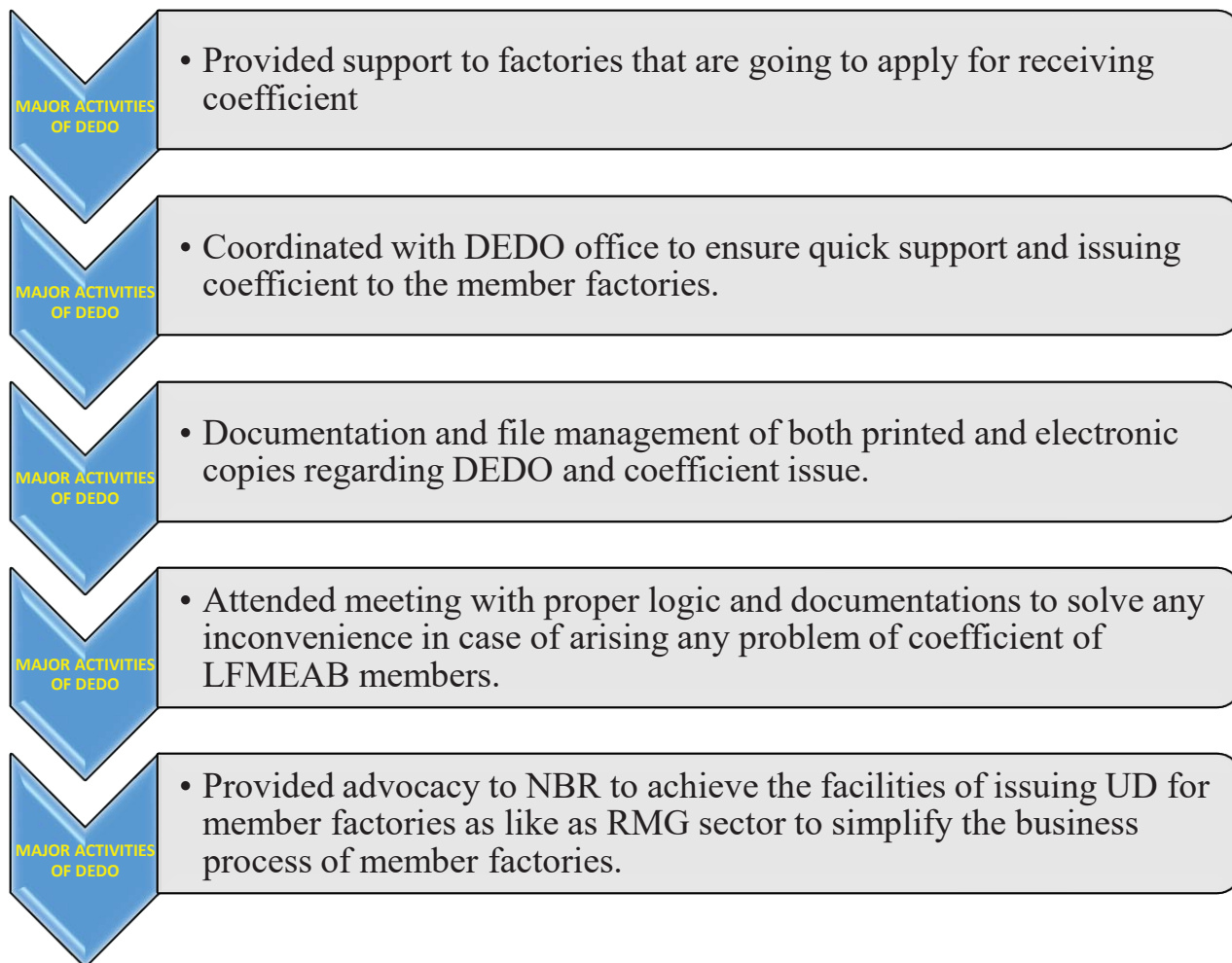
With the support of UNDP, for the first time LFMEAB has published **Decent Workplace Toolkit** to ensure decent work environment for the workers into the factories. A dissemination

workshop and 3 trainings for mid-level management have been arranged for practicing decent behavior to the workers.



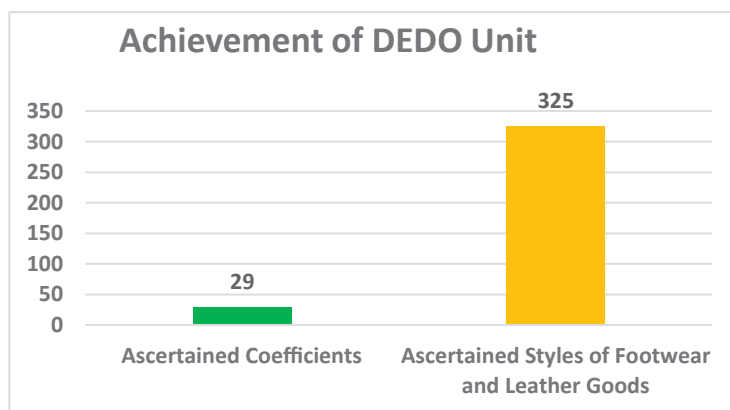

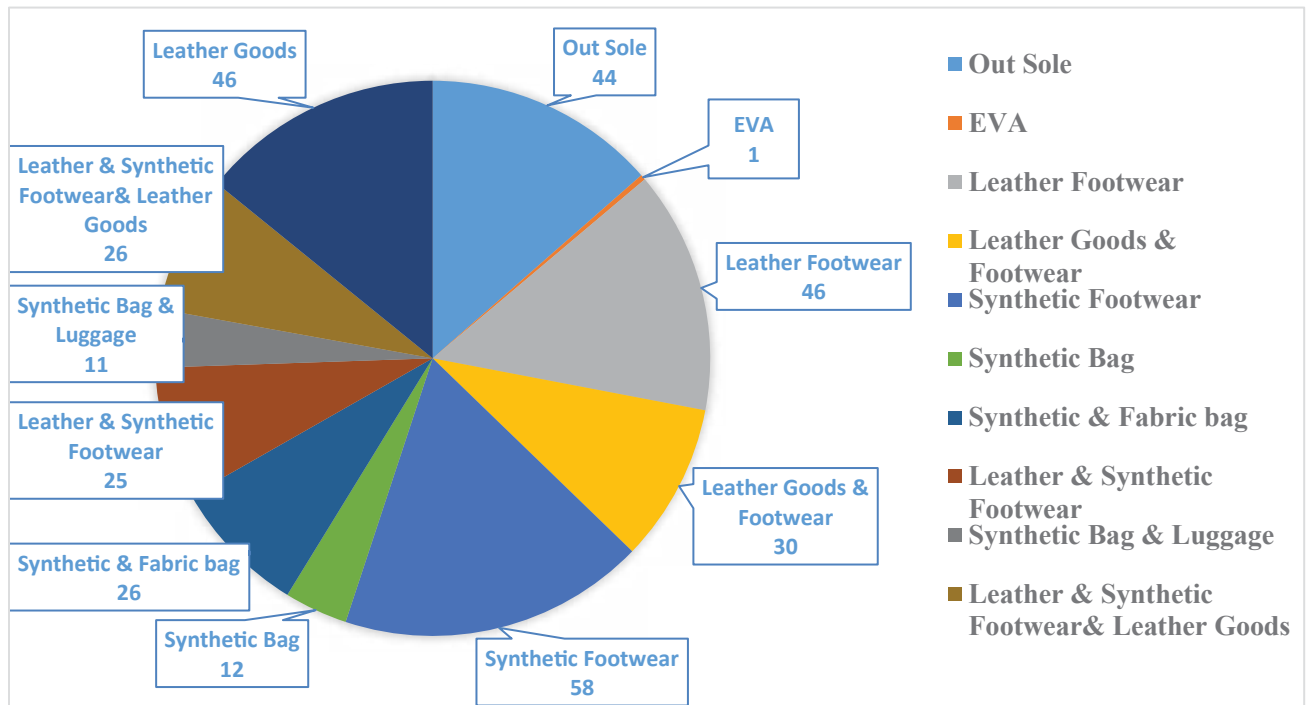

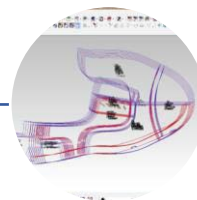

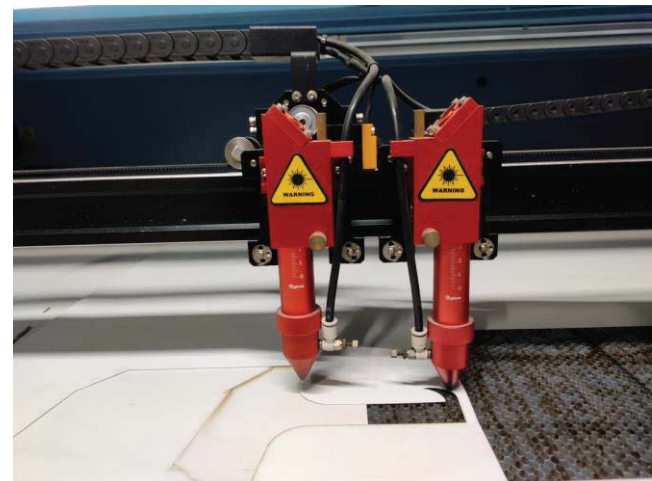

# LFMEAB-SEIP Skill training program for Leather Sector

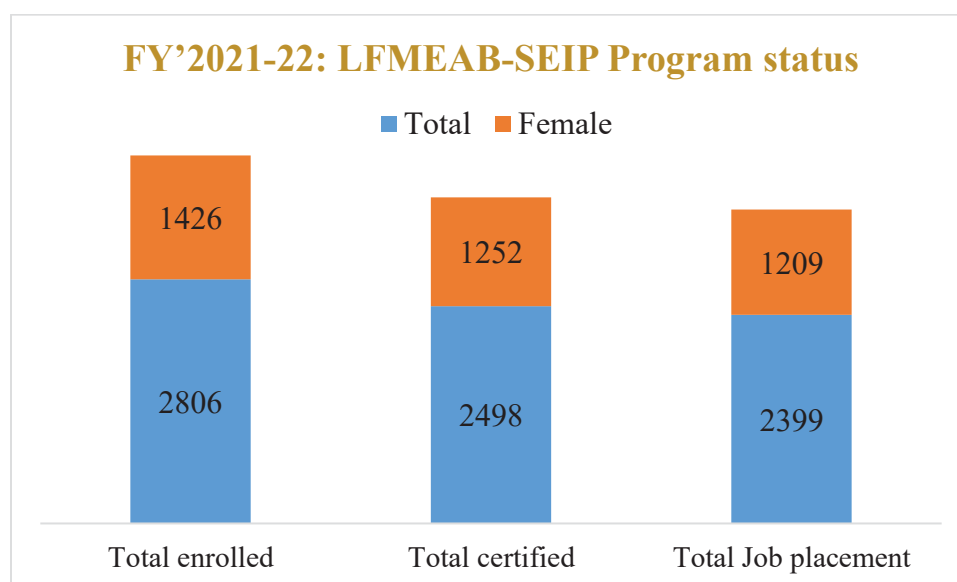
## Key Achievements

LFMEAB in cooperation with Skills for Employment Investment Program (SEIP), Finance Division, Ministry of Finance, Bangladesh and ADB is implementing a skills development project heading “LFMEAB-SEIP

Skills Training Program”. LFMEAB-SEIP has successfully completed its Tranche-01 (2016-17) with 4860 trainees & Tranche-02 (2018-2021) of the program with training target of 10,140 (regular) and additional 961 (against dropout) trainees’ enrollment. “Tranche-03” of the program commenced on January 2022 and the program is ongoing with a target to train 10,000 unskilled manpower for the sector till December 2023.

## Some key achievements of the program

- In last two tranches LFMEAB-SEIP has trained total 15, 000 unskilled workforces with new entrant and upskill training for the leather goods and footwear industry. During FY'2021-22, LFMEAB-SEIP has newly trained 2806;
- 60% of total trainees are female;
- LFMEAB-SEIP has excellent record of job placement in Tranche-01 and Tranche-02 job placement were above 95.69% and 93.53% accordingly. During FY'2021-22, LFMEAB-SEIP has placed 2399 trainees in industrial jobs, which is 96% of certified trainees
- Through this initiative in FY'2021-22, LFMEAB-SEIP has expensed BDT 74,052,321 to the sector for developing skilled manpower;
- In Tranche-02 LFMEAB-SEIP has enrolled 36 physically challenged trainees of which 31 were certified and placed in jobs. In first half of Tranche-03 LFMEAB-SEIP is continuing the effort to recruit trainees with special needs;
- LFMEAB-SEIP enrolled 142 trainees in last two tranches from ethnic minority groups of which 122 trainees are certified and 121 trainees are placed in jobs;
- In the continuing phase Tranche-03 the practice of recruiting physically challenged, ethnic minority group, socially disadvantaged, and women are still a priority and 16 trainees are recruited with some form of physical challenges, and 39 trainees from ethnic minority group among them 10 physically challenged and 26 ethnic minor trainees are in service.

**1.00 Background:**

**1.01 Legal form of the Organization:**

Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh (LFMEAB) was established in 2003 as a company limited by guarantee and registered under section 28 of the Companies Act, 1994.

**1.02 Objectives of the Organization:**

LFMEAB is actively promoting vocational training and skill development programs as well as improving working conditions through schemes such as life insurance, health coverage and WPPF.

**2.00 Significant Accounting Policies:**

**2.01 Basis of Accounting:**

The financial statements have been prepared using cash basis of accounting on going concern concept except statement of receipts and payments.

**2.02 Property, Plant and Equipment:**

The cost of an item of Property, Plant and Equipment is recognized as an asset if, it is probable that the future economic benefits associated with the item will flow to the organization and the cost of item can be measured reliably. Property, Plant and Equipment are stated at cost less accumulated depreciation. Cost represents the cost of acquisition includes purchase price and other directly attributable cost of bringing the assets to working conditions for its intended use. Only the assets of the Head Office is shown as Fixed assets and assets purchase under projects is shown under the head Equipment and supplies.

**2.03 Depreciation:**

**2.05 Provision for Liabilities:**

Provision and accrued expenses are recognized in the financial statements when the organization has a present obligation resulting from past events and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation, and a reliable estimate of the amount can be made.

**2.06 Foreign Currency Transactions:**

LFMEAB maintains its books of account in Bangladeshi Taka. Transactions in foreign currencies are accounted for in Bangladeshi Taka at the rate of exchange ruling on the date of transactions.

**2.07 Capital Fund:**

Leathergoods And Footwear Manufacturers & Exporters Association of Bangladesh is registered with the office of the Registrar of the Joint Stock Companies and Firms, Government of the People's Republic of Bangladesh under Section 28 of the Companies Act 1994 as a company limited by guarantee and without capital. The capital fund represents excess of income over expenditures.

**2.08 Reporting Period:**

These financial statements covered one year from 01 July 2021 to 30 June 2022 which is followed consistently.
