

Sectoral export performance report April 2023

Summary

Although the export performance of total sectoral (leather, leather products, and non-leather footwear) export performance for the current FY 2022-23 July-April. (10 months) reached 1398 USDM, with export growth of just less than 1% over the SPLFY, the export trend of April'23 over March'23 has shown negative growth in almost all products except Leather (Chapter 41) as illustrated in the infographic below:




- In 2023, in 4 months: January-April, total sectoral (leather, leather products, and non-leather footwear) export is over **509 USDM** whereas it was over <u>604 SDM in 2022</u>, with almost <u>16% export fall</u> over the Same Period Last Year (SPLY).
- In 2023, 4 months: January-April, the <u>total export of leather products (42-43) & leather footwear combined</u> is **330 USDM** which was 380 USDM in SPLY, <u>with export earnings down over 13% in 4 months of 2023; and the export share of leather products & leather footwear combined</u> is almost 65% of total sectoral export in 4 months of 2023.
- In 2023, in 4 months: January-April, in terms of <u>only leather footwear export</u>, total export is over **197** USDM, which was <u>257 USDM in SPLY</u>, <u>with export earnings down by **23%** in 4 months: January-April of 2023; and the export share of <u>only leather footwear</u> is almost <u>39%</u> of total sectoral export in 4 months of 2023.</u>
- In 2023, in 4 months: January-April, in terms of <u>only leather products export</u>, total export is almost over **133 USDM**, which was over 123 <u>USDM in SPLY</u>, with <u>export earnings of over **8%**; and the export share of <u>only leather products</u> is <u>**26%** of total sectoral export in 4 months of 2023.</u></u>
- In 2023, in 4 months: January-April, in terms of <u>only non-leather footwear export</u>, the total export is over **140** USDM, which was over 162 <u>USDM SPLY</u>, with <u>export earnings down over **13%**; and the export share of <u>only non-leather footwear</u> is over <u>27%</u> of total sectoral export in 4 months of 2023.</u>



■ In 2023, in 4 months: January-April, the <u>export of Leather</u> (Chapter 41) is **39** <u>USDM</u>, which was over <u>61</u> USDM in SPLY <u>with almost **37%** export down in 4 months of 2023; and the export share of leather is almost <u>8% of total sectoral export in 4 months of 2023.</u></u>

Export performance of leather, leather products, and footwear for FY 2022-23 July-April (10 months)

- Export performance of leather, leather products, and leather footwear for the current FY 2022-23 July-April (10 months) has reached almost 1007 USDM; sectoral export down almost 0.5% over the SPLFY.
- In the current FY 2022-23 July-April (10 months), in terms of <u>non-leather footwear, it exported 391 USDM</u> with export growth of 4% over the SPLFY.
- Export performance of **total sectoral** (leather, leather products, and <u>non-leather footwear</u>) export performance for the current FY 2022-23 July-April (10 months) reached **1398 USDM**, with export growth of just less than **1%** over the SPLFY.
- It is important to note that export performance for July-April 2021-22 over the strategic export target is underperforming in all product categories.
