- 21) Provisional membership will be issued 21 working days from the date of application.

## **Additional Requirements**

- (a) Factory building/ shed should have at least two unobstructed exits of not less than 1.15-meter width & not less than 2 meters height.
- (b) If the factory is in a multi storied building then, it requires to have an emergency exit stair with both side hand rail.
- (c) An emergency assembly point in front of the building/structure is required as well.
- (d) Safe electrical installation
- (e) Fire safety as per the instruction of FSCD.
